#### General Redevelopment Process of Brownfield Sites

- **1. Identify Brownfield**
- 2. Assess/Investigate Brownfield
  - Phase I/II
    Environmental Site
    Assessment.
    - Confirm or refute the presence of contamination





#### General Redevelopment Process of Brownfield Sites

- 3. If necessary, additional investigation & cleanup of a Brownfield site can be done under the NDEQ'sVoluntary Cleanup Program (VCP).
  - The VCP is a fee based program that helps guide a site through cleanup and to a No Further Action status.
  - Eligible cost under EPA's Cleanup Grant
- 4. Redevelop property



### NDEQ's Assistance to your EPA Grant Application

- Review Drafts of your grant application offering editing and ideas for improvement.
- Provide a <u>formal letter of support</u> a requirement for your application.



### NDEQ can best help your EPA Grant Application when....

- A few months in advance....we can suggest "actions to take" to improve your grant application
- Allow time for multiple iterations, we may be reviewing more than one grant application.
- Make it stand out; box in or break it up, make it visual appealing



#### **Most common improvements**

- Follow the guidelines, address each criterion individually.
- Describe your budget in detail.
- Paint a verbal picture of your brownfields community. Follow it up with statistics.



#### **Most common improvements**

- Tie the beginning need to the end story.
- Explain why this project is so important for the community. Make the reviewer cry.
- Be concise. Maximize impact. Your reviewer has very little time. They may be from a different part of the country.

# What can NDEQ do to help if you are not ready to apply this year?

- \* NDEQ's Section 128(a) program provides assistance to assess and clean up brownfield sites (clean up money is very limited) at <u>no cost</u> to the community
- \* NDEQ typically does not provide money. NDEQ uses our contractors to perform the S128(a) investigation
- \* NDEQ is available to meet and discuss the Brownfield and Voluntary Cleanup Programs
